In addition to the technical overhaul, Taxhead has also undergone a number of personnel changes. An interdisciplinary team of several people is available to advise platform users: from questions about profile or vacancy creation, to uncertainties about matching, to advice on contract negotiations.

The team also verifies each individual candidate manually in order to offer companies the highest possible quality of the applicant pool. Likewise, of course, vice versa: each company that registers is checked individually. Only approved profiles are admitted to the matching process.

Through the close hand-in-hand work between programming, talent management and consultants, Taxhead creates a unique user experience that has already benefited hundreds of applicants and companies.

Big goals

The tax and audit sector is an industry that remains stable and even continues to grow despite the pandemic impact. This ensures the basis for a commercially successful future at Taxhead. The company has set itself big goals for 2021: doubling the previous year's figures is just one of them.
